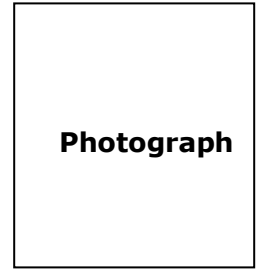

## CHECKLIST FOR ADMISSION PROCESS

1. Copy of previous year's marks sheet.
2. Three passport size photographs.

### Terms & Conditions

1. Registration fee **Rs.5000** to be deposited at the time of enrolment.
2. Fee to be deposited at the time of admission by cash or cheque in favour of **Shree Egurucool/Egurucool Institute**.
3. Rest of the amount to be deposited in two installment by 7<sup>th</sup> of the subsequent months through 2 post dated cheques or cash.
4. **In any case refunding/adjusting of fees will not be done.**
5. **In case if any Student/Parent/Guardian misbehaves with any staff member of the institute, student can be rusticated and no claim of refund of such student will be entertained. The decision of the Managing Director will be final and binding on the Student and Parent/Guardian.**
6. **A student is not allowed to carry mobile phones/I-pod in the classes. If they carry in the classes, then it should be switched off. The Institute is not responsible for any loss/theft in the institute (such as mobile, camera, cycle, motorcycle etc).**
7. **Each student will be issued an Identity card. The entry in to the classes/Institute will be only with Identity Card. If the identity card of a student is lost/misplaced, a duplicate I-card can be asked from the Institute against payment of Rs.200/-. If any student is found misusing the I-card, he/she will be rusticated from the Institute.**
8. Attending every class and appearing for test are compulsory.
9. In case of absence owing to some genuine reason, the student should produce application on the next day and collect the assignment if any.
10. Non-compliance to any instruction can result in expulsion / termination from the institute.
11. Crackers, Cameras, CDs, Magazines and weapons or any objectionable material are strictly prohibited in the centre.
12. Care must be taken of all institute's property, any damage done will be made good by the student concerned , together with a heavy fine imposed on him/ her for such an offence.
13. **If at any point of time, the Central Govt. further increases G.S.T, the extra amount of G.S.T will be borne by the student from the date of enforcement of the act by the Govt.**
14. In case of any dispute or difference between you and Institute regarding the interpretation of these terms and conditions, non-payment of any claim or any dispute arising out of or in pursuant to these terms and conditions, the same shall be referred to Sole Arbitrator who shall be appointed by Director of **Shree Egurucool/Egurucool Institute**. The proceedings shall be conducted at **Patna** under the provisions of Arbitration & conciliation Act and the Courts at Patna only shall have the jurisdiction over the matter and/or for enforcement as the case may be. If an Arbitration to whom the matter is referred refuses to act or for any reason, does not enter the reference or after entering into the reference proceedings are abandoned or kept in abeyance or not proceeded with, it shall be lawful for the Director of **Shree Egurucool/Egurucool Institute**. to appoint another person to act as Arbitrator in the manner aforesaid. Such person shall be entitled to proceed with reference from the stage at which was left by his predecessor, if both the parties consent to this effect, failing which the Arbitrator will be entitled to proceed denovo.
